Faith integration is essential to the mission of all programs at Christian colleges and universities. As educators, we are not only challenged to equip our students with a Christian worldview, but also a view of our discipline that is distinctly Christian. As an academy, we have written numerous articles on styles of Biblical integration, methods and tools to achieve integration, and case studies on results of integration (Dupree, 2015; Kaak, 2016). Yet despite a wealth of research on faith integration, faculty lack validated scales to help in our assessment (Smith, 2005; Holder, 2006; Kaak, 2016). As part of this, our current means of assessment do not consider all of the aspects of the attitudes related to the Christian commitment of the individual.

In this session, participants learn about a research study focused on undergraduate business majors resulting in the development of the Christian Commitment Index which measures students' commitment level to the Christian faith while attending a Christian college or university. The study was conducted with 705 participants across 12 CCCU institutions. Findings indicate that higher scores on the CCI corresponded to more appreciation of faith instruction in their major and integration of their faith in their work after graduation.

Session participants will also engage with authors related to these, and additional, significant findings of the study and explore their various faith integration methods relative to those expressed by institutions engaged in the research study.

Finally, since biblical integration efforts aim toward helping students grow in their faith, should not their individual faith commitments be considered our work? Join us as we explore this critical aspect of our teaching.

Though Vanguard University has valued academic faith integration (AFI) from its founding, a task force began meeting in fall '23 to discuss and define AFI in Vanguard's unique setting. The group examined AFI conceptually, worked on developing a shared definition, had meaningful interactions with faculty, considered faculty development, anticipated places of openness and resistance, and empathized with realities faced by various disciplines. **AI in a Christian School - Year Zero**

In this session, we examine the intersection of faithfulness and artificial intelligence at the locus of a Christian school in order to challenge widely held assumptions about ethics, technology, and pedagogy. Our conversation on Artificial Intelligence integration will begin with a clear and cogent grounding in theological and missiological frameworks. We will provide insights into the case study of Year Zero for Renton Prep's radical and visionary mid-year AI organizational shift. We explore what this case study could mean for the future of Christian education and our role as stewards of this amazing world and all of the wonders in it (Genesis 1:28).

**A study in progress: The impact of centering prayer in classroom settings on academic persistence, emotional well-being, and spiritual development**

Mindfulness, grounding, and meditative practices have been found to have positive effects on student well-being and academic persistence such as stress reduction, increased focus, and increased feelings of relaxation (Chiang & Sumell, 2019; Strait, et al., 2020). However, Christian contemplative prayer practices in a faith-based classroom have not been explored. This project seeks to close that gap by investigating the impact of centering prayer as a contemplative practice, rooted in the Christian faith tradition on students. This qualitative research project will gather data via semi structured interviews, conducted during focus groups with students who have practiced centering prayer which has been integrated into their classroom lessons.

Since January of 2019, I have implemented the practice of centering prayer into each of my classes as a central component of my teaching pedagogy. Over the past 5 years, students have anecdotally reported increased rates of relaxation and focus, as well as overall stress reduction. Students have also reported a positive impact on their overall spiritual development in a Christian context, and some have continued the practice of centering outside of the classroom environment. Focus groups were conducted with students during the Fall semester of 2023 to gather the experiences of the impact of centering prayer during class. This presentation will provide an overview of the implementation of this project and initial observations gained as a result of conducting the focus groups.

There are many questions about the ethical use of generative AI in teaching and learning. ### **The complementary connection between social work values and Christ-centered values**

The discipline of social work is rooted in core values that most would agree are laudable. For Christ-centered social workers, the values of service, human dignity, the importance of human relationships, social justice, integrity, and competency are also fundamental values of the faith. Social work core values were literally taught and lived out by the author and finisher of our Christian faith, Jesus Christ. The social work curriculum is built on core values and competencies that students must demonstrate to complete successfully. Social work is a social science that depends on relationships and evidence-based, effective interventions. Social work began with private Christian organizations serving people experiencing hardships. Over time, social work practice was incorporated into government institutions that did not allow faith-focused service delivery. The field has become increasingly secularized, leaving many uncertain about how to integrate their faith into their practice. This workshop explores the connection between social work's core values and Christ-centered values. It offers guidance on integrating faith into social work practice by connecting social work core values and Christ-centered values. Ethical faith integration in social work practice strengthens the practitioner and the client/consumer. Uncertainty about ethical faith integration in social work can undermine intervention efforts. Social work faculty who emphasize social work and Christian value connectedness can effectively support students exploring their faith while learning the foundations of social work and developing their professional identity. Social work students who learn to ethically integrate faith into practice can provide social work services more confidently.

### **Sharing the Gospel with Christian [and Non-Christian] Students in the Faith-based University Classroom**
